At the outset, the Vice-Chancellor Prof. Atal Chaudhuri, Chairman Board of Management welcomed the members present in the 29<sup>th</sup> Board of the Management as wells the new members appointed from the Alumni VSSUT, Burla and AICTE Nominee

Then the agenda items were discussed and resolved as follows:

**BOM: 29-01:** To confirm the minutes of the 28<sup>th</sup> meeting of the Board of Management held on 17.11.2018 (**Annexure-I**): Pages from 7 to 11.

Resolution: Confirmed as there were no comments from the members.

BOM: 29-02: Action taken report on the minutes of the 28th meeting of the Board of Management held on 17.11.2018 (Annexure-II): pages from 12 to 15.

**Resolution:** Action taken report on the minutes of 28<sup>th</sup> BOM meeting was discussed in detail & approved with the followings.

**Item No. 27-06**: Vice Chancellor is requested to explore the possibility of funding from Self Finance fund of the University in the tune of 2 crores to start the construction of Sport Complex, tentative cost of 10 crores. Further Mr. Bimal Kumar Mishra was requested to explore Government funding to meet the differential amount.

**Item No. 27-12**: Rehabilitation Assistance Scheme for Non-teaching employees of VSSUT be implemented according to existing Govt. of Odisha rules. Registrar is requested to process through seeking the necessary concurrence from Govt. By citing the examples of such implementation in Sambalpur University.

Item No. 27-13: The current status of university automation has been presented in presence of OCAC at Bhubaneswar on 14th January 2019 as per official communication vide letter no. SDTE-HTE-HTE-II-0001- 2019-73, Bhubaneswar, Dt. 07.01.2019. A State Level Committee is already formed with Prof. Debdutta Mishra as member from VSSUT. The current ongoing process for university automation to be continued as was initiated. Dr M. R. Senapati, PIC, Automation for VSSUT shall expedite the automation work for the university with due consultation with Prof. D. Mishra, Member State Level Committee for Automation.

**Item No. 27-14**: Campus wide WI FI be initiated immediately as it is highly recommended by the member for University fund.

Item No.27-16: It is reported that Govt. of Odisha is in the process of implementing CAS for the teachers however additional increments for Ph.D/M.Tech/M.Phill is not considered at present. However, the Board Members feel that it can be further pursued with the Govt. citing examples of such benefit availed by the faculty members of other Universities.

**Item No. 27-22**: Land at Chandaka, Bhubaneswar is already registered in the name of VSSUT. Boundary wall is in progress as reported by Mr. Bimal K. Mishra. Vice Chancellor is requested to allot notional fund to engage an architect for preparing the drawings and detailing of the proposed building.

**BOM: 29-03:** To consider and approve the recommendations of the 18th meeting of Finance Committee held on 18.03.2019.

**Resolution**: Approved with the followings.

The Board approved item FC:18-6 as follows.

The members considered the Item (under FC:18-6) and approved and confirmed for collection of additional amount of Rs.4,000/- (Rupees four thousand only) in each Semester from all Hostel Boarders from next Academic Session (2019-2020) and the fund will be kept in the Corpus name "Student Contributed and Operated Corpus Fund" and the operational modalities regarding expenses of the fund are left to the Vice-Chancellor.

## Any other items.

- A. (i) The Board discussed the proposal for calculation of pension and terminal benefits for the employees at the age of 60 years instead of 58 years and decided to move with the Govt. of Odisha.
  - (ii) The Board approved the following comprehensive amendment of Clause 13.1 of VSSUT Statute with deletion of the last sentence:
  - "However, the age of retirement of teachers will be as per the AICTE rules and guidelines amended from time to time". After amendment of the Clause 13.1 of VSSUT Statute to be read as:
  - "The age of superannuation for all officers (except Vice-Chancellor) including teachers and staff of the University Department shall be 60 years. In case of those deputed from Government, relevant rules of parent department shall be applicable".

The Committee also requested to revisit the entire VSSUT First Statute 2010 and subsequently forward it to the Govt. of Odisha for necessary ratification in this regard.

- (iii) Pending amendment of the VSSUT First Statute 2006, the Board decided to move to the Govt. for permission for release of Pension and terminal benefits to the petitioners at 60 years of age (i.e. date of Superannuation) to comply the contempt proceedings against the VSSUT, Burla.
- (B). The members were concerned for non-implementation of resolution (BOM: 27-05) admission into B.Tech programme through lateral entry mode limiting to 5% of sanctioned strength. Hence, it is strongly recommended to be implemented positively from next academic year (2019-20), with a communication to Govt. & Chairman OJEE- 2019. Registrar should ensure that in the seat-matrix to be prepared for OJEE-2019, the number of seats for B.Tech admission through lateral entry mode for VSSUT, Burla to reflect accordingly in consultation with Dean, Academic Affairs.

- (C). All members agreed to write to Govt. in the status of resolution no. BOM:27-05 with regards to VSSUT's own counselling cum admission process in to B.Tech programme from JEE (Main) and JEE (Adv.) instead from OJEE counselling, satisfying all the Govt. of Odisha norms with regards to reservation in admission, as this will help not only of getting high ranking students but the 1st Semester classes can be started in the month of July instead of August to meet Semester's academic calendar requirements. Further, this will help in VSSUT's brand building exercise immensely.
- (D). The Chairman reported to all the members about the suspension of Dr. Rakesh Mohanty, Associate Professor in the Dept. of Computer Science & Engg., Which is sub-judice under Honourable High Court. This court case is assigned to handle by Advocate Diptiranjan Mahapatra on behalf of University
