As per the decision of the Government of Odisha communicated through letter No.1-TTI-87/2013/4778/ETET, Bhubaneswar dated 14<sup>th</sup> August 2013, counselling for admission into 59 nos. vacant seats of B.Arch Programme 2013 shall be held on **24.08.2013** at VSSUT, Burla basing upon the OJEE 2013 merit list of the candidates who have secured at least 50% or more marks in aggregate in +2 level with Mathematics as one of the subject and having the NATA Score. The eligible candidates interested to take provisional admission into B.Arch. Programme 2013 at VSSUT, Burla may attend the counselling to be held on **24.08.2013 at Sir Visveswaraya Auditorium, VSSUT, Burla** with Original Rank Card issued by OJEE 2013 and original NATA Score Card alongwith other required documents. The fees structure and list of documents required at the time of admission are enclosed herewith for information of all concerned. **There are limited seats available in the Hall of Residence. If allotted, the hostel fees of Rs.22, 000/- per annum will be collected on the spot through bank challan.** Hostel accommodation shall be made strictly on merit basis. Those who will not be given hostel accommodation, they have to arrange their own accommodation in the vicinity of Burla.
