In pursuance to Govt. of Odisha (SDTE department) order No.PT2-SDTE-HTE-HTE-I-0003-2017/3642/SDTE,Dated.03.08.2018, the following non-allotted seats by OJEE 2018 shall be filled up through spot admission in two phases. The spot admission schedule is as follows.

The following modalities will be followed during spot admission

1. Candidates having valid Rank Card issued by OJEE 2018 shall participate in the spot admission.
2. The candidates who have got final allotment in OJEE 2018 counseling process and have already taken admission in any of the technical college of the state are not eligible to participate in Government College spot admission process.
3. OJEE-2018 rules and regulations will be followed during spot admission.
4. The total admission fees is Rs.85110/- . However, the selected candidates shall have to deposit the part admission fee of **Rs.10,000/- (Rs.5,000/- in case of SC / ST candidates)** along with the counseling fee of Rs.450/- on the same day to confirm his / her allotment. Balanced fees (General Category Rs.75110/- and SC/ST Category Rs.80110) have to be deposited in shape of Demand Draft.
5. The guidelines and eligibility criteria prescribed by the AICTE / Govt. of Odisha / OJEE will be strictly follows for final admission.
6. The candidates have to deposit fees in shape of Demand Draft made through any national bank issued in favour "VSSUT, Burla" payable at Burla.
7. The candidates are required to bring one set of Xerox copies of all relevant documents along with all original documents as per OJEE 2018 counseling.

NB: Without Demand Draft, OJEE Rank Card, Original CLC/TC, candidates will not be allowed to participate in spot admission.
