1. Eligibility for 5-Years Integrated M.Sc Programme :

Passed or appeared in 2013, 10+2 examination of CHSE, Odisha/CBSE/ICSE or equivalent examinations with Physics, Chemistry and Mathematics as compulsory subjects along with one of the subjects from Biotechnology / Biology/ Technical Vocational Subject / Electronics / Computer Science / Information Technology/ Geology / Statistics. The candidate should have passed individual subject and must have obtained at least 45% marks (40% in case of candidate belonging to SC/ST category) in the above subjects taken together. There is no age limit to appear at VSSUT Entrance Test-2013 for admission into 5-Years Integrated MSc courses in Physics/Chemistry/Mathematics. The candidates must submit appropriate course completion certificate from the Head of the Institution, which they last attended, and copies of mark/grade sheets.

2. Subjects for appearing at VET-2013:

All candidates seeking admission to 1st year of 5-Years Integrated MSc in any subject shall have to appear in Physics, Chemistry and Mathematics (60 questions in each subject) for a total duration of three hours in one sittings (as per standard syllabus of CHSE/CBSE/ICSE)

3. Examination Procedure / Valuation methodology:

There will be multiple choice type questions. The number of questions will be sixty (60) per each of the above mentioned subject of examination. Each question shall have four answers (including one correct answer) and the examinee shall have to put a cross mark (X) only the appropriate answer (which he/she considers most correct) in black / blue ballpoint pen. Each correct answer shall fetch four marks. Each unattempted question will fetch zero. There is no negative marking. If more than one answer are marked for one question, it will be treated as an incorrect answer.

4. SUBMISSION OF COMPLETED APPLICATION FORM

The interested Candidates shall download the application form from the University website: www.vssut.ac.in and send a hard copy of the completed application duly signed by the candidate alongwith the documents mentioned below by speed post so as to reach the Registrar, VSSUT, Burla **by 13th July 2013**.
