1. **Eligibility for Ph.D Programme**

Ph.D programme is conducted by all the departments of the University in various field of Engg./Science: Civil Engg./Mechanical Engg./Electrical Engg./Electronics & TCE/Computer Science & Engg./ Manufacturing Science & Engg/ Physics/Chemistry/Mathematics

One of the following shall be the eligibility criterion for the admission to Ph.D. programme of the University

- i) M.E/M.Tech/M.Phil with minimum of 6.75 CGPA in 10 point scale (or 60% or more in aggregate) in Master's level and minimum of 6.75 CGPA (or 60% mark in aggregate) at the Bachelor's level.
- ii) B.Tech/MCA with uniformly good academic career and not less than 7.75 CGPA (70% marks) at Bachelor's/Master's level.
- iii) M.Sc. with 60% or more.
- iv) GATE qualified candidates/NET qualified candidates with not less than 60% score at Bachelor's and Master's level.

Above requirements may be relaxed for the following

- i) Faculty members employed on permanent positions of VSSUT, Burla having M.E/M.Tech/M.Phil.
- ii) Sponsored candidates with M.Tech/M.Sc./MCA/B.Tech/M.Phil with not less than 60% in Bachelor's level and Master's level working in National Laboratories, R&D/AICTE recognized degree institutions of the Central and State Government departments and R&D Laboratories of reputed industries in permanent positions with three years of experience.

2. Selection Criteria for Ph.D Programme

The selection shall have the following three components for General/SC/ST candidates as follows:

- i) Written test (40 marks) out of which 20 Question multiple choice @ 1 mark each and 10 Questions objective type @ 2 marks each. The qualifying marks shall be 40% for written test. For other components such as : Interview performance and career marking, the qualifying marks shall be 50%.
- ii) Interview performance: 30 marks
- iii) Career markings : 30 marks

The regular faculty of VSSUT employed in permanent positions shall be exempted from the written test.
