The list of the qualified candidates for the admission into Ph.D Programmes – Autumn 2024, is enclosed herewith. All the qualified candidates have to physically report on 26/07/2024, 10 AM at *E-Learning Centre, Veer Surendra Sai University of Technology, Burla* along with the relevant documents as mentioned below. *No separate Offer letter will be sent to the qualified candidates. Candidates are suggested to come prepared to pay the admission fee through online mode*, after the physical verification of documents. Candidates may also avail hostel accommodation at VSSUT, after completion of admission process. Candidates selected under the category, “Fulltime students with University Fellowship/ Assistantship” will receive a monthly fellowship of Rs. 12000/- for first two years and a fellowship of Rs. 14000/- in third year with a contingency of Rs. 25,000/- per annum (up to 3years). The fellowship will be automatically cancelled if the progress of a candidate observed to be unsatisfactory. The scholar admitted under University Fellowship and Project Scholars categories have to take 10 hours of teaching load per week. The authority reserves the right to accept/reject any application or cancel the entire selection process without assigning any reason thereof.
