4. The Quotationer shall quote the unit price and taxes and other duties livable, if any on the cost separately.
5. 90% of the billed amount shall be paid within 15 days of complete installation & Commission and running of the Network and 10 % of the bill will be released after next 15 days of testing of connectivity and satisfactory running.
6. The Quotationer shall submit valid GST certificate along with the bill before release of payment.
