SECTION-II: GENERAL TERMS AND CONDITIONS

GENERAL TERMS & CONDITIONS OF CONTRACT FOR SUPPLY OF CERAMIC COMBO BOARD (GREEN & WHITE) SIZE 12'X4' FOR CENTRAL STORE & PURCHASE, VSSUT, BURLA, ODISHA.

1. EARNEST MONEY DEPOSIT. All bidders are required to submit EMD of Rs. 10,000/- (Ten thousand only) in shape of Demand draft drawn in favour of "Veer Surendra Sai University of Technology, Burla" payable at SBI,Burla only. The EMD shall be in Indian Rupees.

NOTE: Non-submission of EMD or submission of less EMD than the desired one shall result in rejection of Bid. The EMD deposited against other Bids cannot be adjusted or considered for this Bid. No interest is payable on EMD.

2. PROCUDURE FOR SUBMISSION OF BIDS.

The Bids shall be submitted in sealed envelopes as under: -

- a) Should contain the Bank Drafts (s) for the (i) TENDER COST (ii) Earnest Money Deposit (EMD).
- b) Tender Document duly signed by the bidder at respective page and all photocopies of the necessary documents to be submitted along with the GST Regd.No certificate, valid TIN No and PAN NO.

The bidder must put his seal and signatures on each page of the bid If the rate written in handwriting text, must not be rewritten and also attest all or corrections etc., if any, under his seal and signatures.

- **3.** BIDDER QUALIFICATION. The bidder should have minimum three years' experience in the field of supply of General Office Stationary Materials in Educational Institution / Govt. Organisation / Public Sector. The minimum annual turnover of the prospective bidder should be Rs.10.00 lakh per annum during the last three preceding years.

5. TERMS AND CONDITION OF CONTRACT

- **5.1** The Bids shall be opened at VSSUT, BURLA by a duly constituted Committee in the presence of such Bidders or their authorized representatives who may desire to be present at the time of opening of bids.

The bidder should sign undertaking along with the bid document that he / she has read the complete tender document and will abide by its terms & conditions.

- **5.3.**The bid shall contain no eraser or overwriting except as necessary to correct errors made by the Bidder, in which case such corrections shall be authenticated by the person or persons signing the bid.
- 5.4. Bid Documents are neither transferable nor cost of the bid documents is refundable under any circumstances.
- 5.5. The issuing of bid document shall not constitute that the bidders are automatically qualified.
- 5.6 If even after award of contract, information/facts submitted by the bidders are found misleading/incorrect/false etc., VSSUT, BURLA reserves the right to terminate the contract.

- 5.8 The successful bidder will have to supply of Ceramic Combo Board at VSSUT, BURLA as per items and Rate as given in the Annexure A attached with price schedule / document to this Tender Document.
- 5.9In case of supply of Ceramic Combo Board, if found less in quantity or quality and not of standard quality or not supplied in time, a deduction of 10% will be made from the bill as penalty or as decided by the competent authority repeated fault may result in forfeiture of part or whole of money and even termination of the contract.
