- 5. The period of warranty shall be indicated clearly and warranty certificate shall be submitted at the time of delivery. During warranty period free replacement of defective batteries shall be made, if any.
- 6. The dealers/suppliers will require to keep/minimum stock of batteries and will replace the faulty battery/batteries within 48 hours of reporting so that University's normal operation will not be hampered.
- 7. EARNEST MONEY DEPOSIT: Earnest Money amounting Rs.1,000/- (Rupees One thousand only) in the form of Demand Draft on a Nationalized bank drawn in favor of Comptroller of Finance, VSSUT,Burla should accompany with the Technical bid. E.M.D. by means of Bank guarantee or any other mode of payment other than DD shall not be accepted.
