4. Taxes as applicable should clearly be mentioned.
5. A demand draft for Rs 500/- (Rupees Five hundred only) shall be paid along with the technical document towards cost of quotation document, failing which the quotation of the bidder shall be cancelled.
6. The period of warranty of switches shall be indicated clearly and warranty certificate shall be submitted at the time of delivery. All switches, software and hardware shall be covered by at least **one year on-site warranty** from the date of commissioning of the project. However, if any individual component has warranty of more than one year offered by manufacturers, the same will prevail.
7. Further, vendors have to provide TWO years *Comprehensive Annual Maintenance Contract* after expiry of warranty period. The offer is to be provided along with the quotation for switches, failing which the quotation shall be treated cancelled.




