3. The vendors having previous experience in this line and also having necessary arrangements for executing such job need apply. Mere participation in the quotation process without any background and quoting lowest price shall not be the criteria for selection.
4. The restoration of ring structure in the campus shall be on turnkey basis i.e. additional works/materials required, if any during the execution for completion shall be borne by the vendor.
5. Modification/ alternation required, if any shall be taken up on the consultation of PIC, CIF.
6. The quotationer shall quote the unit price and taxes and other duties leviable, if any on the cost for both the job separately. The rates quoted by vendors shall valid for at least 120days.
