This has reference to your application dated 17-07-2014 in Tier-I format seeking accreditation by National Board of Accreditation to UG Engineering programmes offered by Veer Surendra Sai University of Technology, P.O. Burla, Dist. Sambalpur, Odisha-768 018.

2. An Expert Team conducted on-site evaluation of the programmes during 29th to 31st July, 2016. The report submitted by the Expert Team was considered by the concerned Committees constituted for the purpose in NBA. The Competent Authority in NBA has approved the following accreditation status to the programmes as given in the table below:

3. It may be noted that only students who graduate during the validity period of accreditation, will be deemed to have graduated with an NBA accredited degree.

4. In respect of the Programmes which have been granted Provisional Accreditation, **Veer Surendra Sai University of Technology, P.O. Burla, Dist. Sambalpur, Odisha-768 018** should submit the Compliance report at least 6 months before the expiry of validity of accreditation mentioned above. It may require submission of pre-qualifiers before sending the Compliance report for granting further Accreditation.

5. The accreditation status awarded to the programmes as indicated in the above table does not imply that the accreditation has been granted to **Veer Surendra Sai University of Technology, P.O. Burla, Dist. Sambalpur, Odisha-768 018** as a whole. **As such the Institution should nowhere along with its name including on its letter head etc. write that it is accredited, by NBA because it is programme accreditation and not institution accreditation. If such an instance comes to NBA's notice, this will be viewed seriously.** Complete name of the programme (s) accredited, level of programmes and the period of validity of accreditation, as well as the date from which the accreditation is effective should be mentioned unambiguously whenever and wherever it is required to indicate the status of accreditation by NBA.

6. The accreditation status of the above programmes is subject to change on periodic review, if needed by the NBA. It is desired that the relevant information in respect of accredited programmes as indicated in the table in paragraph 2, appears on the website and information bulletin of the Institute.

7. The accreditation status awarded to the programmes as indicated in table in paragraph 2 above is subject to maintenance of the current standards during the period of accreditation. If there are any changes in the status (major changes of faculty strength, organizational structure etc.), the same are required to be communicated to the NBA, with an appropriate explanatory note.

8. Copies of the Report of Chairman of the Visiting Team and Evaluators' Reports in respect of the above programmes are also enclosed.

9. If the Institute is not satisfied with the decision of NBA, it may appeal within thirty days of receipt of this communication giving reasons for the same and by paying the requisite fee.
