Resolution: Approved.

BoM: 12-05 To nominate two External members to Academic Council as per VSSUT Act. 2008 under Section 21.2 (b) (i) & (ii).

The two years' tenure of Prof. S. Tripathy, Dean Academic Affairs, IIT, Bhubaneswar & Prof. S.K. Jena, Professor of CSE, NIT, Rourkela as External members to Academic Council has been expired w.e.f April, 2014. Hence, the Board may kindly nominate another two members from IIT, Bhubaneswar & NIT, Rourkela from the panel as furnished below for a period of two years to the Academic Council of the University.

Resolution: Out of the above 05 (five) suggested list, the Board nominates Prof. Pradipta Rath, Professor of Chemical Engg., NIT, Rourkela.(sl.2) & Prof. Swarup Kumar Mahapatra, Professor, School of Mechanical Sciences, IIT, Bhubaneswar(Sl.No.5) as External members for a period of two years to the Academic Council of the University effective from 19.05.2014.

BoM: 12-06 To consider and approve the result of interview for the post of Reader in Mathematics.

Advertisement No.3/11 dated 8.4.2011 was made to fill up the vacant post of faculties and officers of VSSUT, Burla. During the process of recruitment an interim order dated 27.06.2011 passed by the Hon'ble High Court Odisha Vide WPC No.16804 of 2011 and Misc. No.9448 of 2011 filed by Dr. Chittaranjan Dash and Dr.Ashok Mishra with a direction to the opposite party i.e. VSSUT, Burla to allow the petitioner to participate in interview, but result pursuant to the advertisement for the post of Reader in Mathematics shall not be published without leave of the court. The interview for the post of Reader in Mathematic was conducted on 28.6.2011 and both of the petitioners were attended the interview and publish of result was withheld accordingly.

Subsequently, the Hon'ble High Court Orissa vide their judgment dated 9.12.2013 disposed of the WPC No.16804 of 2011 that as the University has already conducted the interview to the posts in question there is no necessity to pass further interim order in the writ petition. However, the result of the interview shall be published by the University within a period of three weeks from today.

In order carry out the direction of the Hon'ble High Court, it is to be pointed out that the Board meeting is to be convened to publish the result as per the VSSUT Act and Statutes. But it was not convenient to call the next meeting of the Board of Management with a very short period to publish the result. Considering above fact, result of the interview conducted on 28.6.2011 for the post of Reader in Mathematics was published accordingly and the appointment order has been issued to the selected candidate. Dr. Susant Kumar Paikray who was selected has already been joined the post of Reader in Mathematics w.e.f. 05.04.2011. This is for information and approval of the Board in Post-facto.

Resolution: Approved in post-facto.

BoM: 12-07

To consider and approve the recommendation of the various Selection Committees for the interviews held from 28.02.2014 to 12.03.2014 in response to the Advt. No.VSSUT/Estt./4658 dtd. 10.12.2013 for recruitment of regular faculties and Officers of the University.

In pursuance of Advertisement vide No.VSSUT/Estt./4658 dated 10.12.2013, the interview was conducted by various Selection Committees from 28.02.2014 to 12.03.2014 for recruitment of 159 nos. vacant posts of regular faculties and officers of VSSUT, Burla. During the process of interview, the Hon'ble High Court, Orissa passed an interim order Vide WPC No.3876 of 2014 and Misc. No.3625 of 2014 filed by Sri Prasant Kumar Pradhan with a direction to the opposite party i.e. VSSUT, Burla to allow the petitioner to

participate in interview scheduled to be held on 2nd March 2014 for the post of Reader in Mechanical Engineering and Reader in Production Engineering. However, the post of Reader in Mechanical Engineering and Reader in Production Engineering shall not be filled up by the Opposite Party No.1 without leave of this Court.

As per VSSUT Act, the recommendations of various Selection Committees for selection of teachers and Officers needs approval of the Board for publication of the result and issue of offers of appointment to the selected candidates. The recommendations of the selection Committees in confidential closed covers available with the Registrar In-charge may please be perused for approval and publication of results except the above categories of posts as recommended by the Selection Committees.

.Resolution: Approved with the following observations:

(i) The publication of result and issue of offers of appointment to the selected candidates (ANNEXURE-A) be made in the first instance except the following posts as these are to be reviewed and suggested by a Sub-Committee formed by the Board consisting of the following to the Vice-Chancellor within 7 days for implementation as the Vice-Chancellor, BPUT, Odisha & Prof. R.P. Panda, Member, BOM opined the receipt of anonymous letter in their addresses regarding the selection of the following posts.

- (ii) Based on the recommendation of the Sub-Committee on the above matter [Item(i)], the Vice-Chancellor is authorised to take follow-up action which will be ratified in the next BOM meeting.
- (iii) The offer of appointment will be made to the wait listed candidate **Dr. Ojaswini**Mohanta (Sl.2 UR) for the post of Lecturer in Physics, in case the No.1 candidate **Dr. Lakshmi Praveen Pogula** (UR) does not turn up.

(iv) Further, as per interim order vide Misc.Case No.3625 of 2014 of the Hon'ble High Court, Orissa passed in connection with WP(C) No.3876 of 2014 filed by Sri Prasant Kumar Pradhan, Lecturer, Mech.Engg.,VSSUT, Burla, the post of Reader in Mechanical Engineering and Reader in Production Engineering shall not be filled up by the Opposite Party No.1 without leave of the Court.

(v) In case of Dr. H.S. Behera, Lecturer (SS) in Comp. Sc. & Engg., the offer of appointment against advertisement No.VSSUT/Estt./4658 dated 10.12.2013 shall be issued subject to withdrawal of all the cases pending against VSSUT, Burla in the Hon'ble High Court, Odisha.

BoM: 12-08 To consider and approve a guide lines for forwarding employees applications for attending interview for recruitment outside VSSUT, Burla.

The Board of Management in its 2nd meeting held on 22.09.2010 was approved the following guidelines for forwarding employees applications for attending interviews for recruitment outside the VSSUT, Burla

- 1. No application of an employee during probation period shall be forwarded.
- 2. Applications of regular faculties for appearing interview for recruitment elsewhere may be forwarded maximum twice a year to be counted from the date of his/her first application.

But it is observed that most of the faculties are submitting their applications for forwarding through proper channel in different categories of post (more than two) to a single institution and to different institutions under one University. Hence, the authority is facing problems for forwarding their applications due to want of clear instructions. Hence, the BOM may pass/approve a clear guide lines for forwarding applications of employees of this University.

Resolution : Approved with the following modifications to the guidelines passed in the 2nd meeting of the Board of Management held on 22.09.2010 as specified above.

- (i) During probation period one can apply any number of application(s) and the authority will endorse the same to the concerned authority for selection of the incumbent. In the event of selection he/she shall be relieved as per University rules.
- (ii) The application of the confirmed employees of the University shall be endorsed 3 (three) times in a calendar year (January-December).

BoM: 12-09 Change of designations of faculty members as per new guidelines (3 Tier System).

We have already conducted the interview for 159 posts (faculty & Officers) and the result will be approved by the Board today (19.05.14) for both the existing vacant posts and newly created posts by the Government.

About the re-designation of the faculty members in the new 3-Tier system a Screening Committee may be constituted by the Vice-Chancellor. The Screening Committee in consultation with the Government will suggest the names of the faculty members with their new designations according to the 3-Tier system. This is for favour of approval of the Board.

Resolution : This is to be finalized following the Resolution No.I-FE-31/2013(pt)/6254 dtd. 25.10.2013 of E&TE&T Department, Govt. of Odisha.

BoM: 12-10: Representation of Sri Rakesh Mohanty, Lecturer in CSE Dept. dated 06.05.2014.

Sri Rakesh Mohanty, Lecturer in Computer Science & Engineering Department of VSSUT, Burla has represented to the Hon'ble Vice-Chancellor and Chairman, Board of Management, VSSUT, Burla, The Commissioner-Cum-Secretary to Govt. of Odisha, ETET Department, BBSR, All the members of BOM of VSSUT, Burla and the Registrar, VSSUT, Burla dated 06.05.2014 to consider his grievances in the 12th Board of Management of VSSUT, Burla. The parawise details are given below.

1) Issue of appointment letter for the Post of Reader in CSE, IT and MCA.

Sri Rakesh Mohanty has attended the interview for the post of Reader in CSE, IT and MCA held during the year 2011. The Selection Committee selected Sri Mohanty for the Post of Reader in CSE, IT and MCA subject to submission of Ph.D thesis. In the mean time, Sri Mohanty filed a Writ Petition before the Hon'ble High Court, Odisha in W.P.C. No.18058 of 2011 and the Court directed the University authority not to publish the result of the interview held on 19.06.2011 till disposal of the writ application. Subsequently, the Hon'ble Court on their judgment dated 8.5.2013 Vide Misc. Case No.20007 of 2012 modified the interim order dated 15.7.2011 to the extend that on post of Reader in Computer Sc. & Engineering, Information Technology and MCA shall be kept vacant till the next date and other posts may be filled up by the University. Accordingly, the recommendation of the Selection Committee was placed in the Board of Management in its 9th meeting held on 21.05.2013. But, the BOM constituted a Review Committee to review the recommendation of the Selection Committee and the same was placed before the 10th BOM meeting held on 30.05.2013. After careful consideration of the reports submitted by the Review Committee, the Board approved the result of the Selection Committees and agreed for

appointment except Sri Rakesh Mohanty, Lecturer, VSSUT, Burla. The case of Sri Rakesh Mohanty be referred to the BOM after decision of the Hon'ble High Court of Odisha. Accordingly, the action has already been taken by the University authority.

2) Issue of appointment letter for the post of Senior Scale Lecturer under CAS.

The applications from the faculty members were called for CAS promotion when it was UCE.,Burla. The Principal, UCE, Burla submitted CCRs/PARs confidentially as available to the BPUT, Rourkela as the UCE, Burla was a constituent college of BPUT for consideration. The candidates attended interview for CAS conducted by the BPUT. The recommendation of the BPUT was received by the authority except Sri Rakesh Mohanty. The reasons not known to this University.

3) Sanction of M.Tech. increment.

Sri Rakesh Mohanty was appointed as a Lecturer in the Department of Computer Science and Engineering on 01.09.2001. At that time he possessed the Qualification of B.Tech. On 04.06.2002, he possessed his M.Tech. degree. On verification of records, it is found that he has not applied for sanction of advance increment for possessing M.Tech. Degree. He has applied for the same in the year 2009. The office order was issued for sanction of one advance increment w.e.f. 04.06.2002 vide office order No.2393 dated 16.09.2009. But, in the mean time, the Revised Scale of Pay of Teachers of Engineering Colleges/Universities under ORSP Rules-2010 was issued where there was no provision for sanction of advance increment for possessing any degree of M.Tech./Ph.D. Hence, no increment was paid to Sri Mohanty. Hence, the BOM may please decide.

Resolution: Resolved that Sri Rakesh Mohanty, Lectuer shall be issued appointment letters for the post of Reader CSE, IT & MCA only after withdrawal of all cases filed by him against VSSUT, Burla.

BoM: 12-11: To consider and approve the candidature for appointment under Rehabilitation Assistance Scheme of the deceased non-teaching employees.

In pursuance of the Recommendation of the District Magistrate and Collector, Sambalpur Vide Letter No.24566/Estt/, dated 31.12.2013, the Government of Odisha ETET Department, Bhubaneswar Vide Letter No.V-FE-2014/2305/ETET, dated 01.05.2014 has approved for appointment of Sri Bishal Rao, S/o Late P.Kishore Rao, Ex-Dresser as per provision of OCS (R.A.) Rules-1990. The minimum qualification for the post of Laboratory Attendant is H.S.C. Accordingly, he has possessed the required qualification for the post

of Laboratory Attendant. Hence, it is proposed to appoint him as Laboratory Attendant against the regular vacant post under Rehabilitation Assistance Scheme. This is for information and kind approval of the Board.

Resolution: Approved with the following observation:

Sri Bishal Rao , S/o Late P.Kishore Rao, Ex-Dresser shall have to qualify in a Computer test, etc. as per the guidelines of G.A. Deptt., Govt. of Odisha. This is to be conducted by an Expert Committee constituted by the Vice-Chancellor. The report of the Committee to be placed before the BOM for approval.

BoM: 12-12: Solicited clarification on the appointments under High Court Order & Rehabilitation Assistance Scheme.

The Hon'ble High Court in their judgement dated 25.09.1992 has stated as follows:

"It is our considered view that prompt steps should be taken for regularisation of the NMRs services in the posts held by them or any other equivalent posts before any fresh recruitment is made to such posts. While considering the case of the NMRs for regularisation in service their inter seniority as NMR workers and expertise acquired by them in different pots will be duly considered."

Accordingly, more than 100 NMRs have been regularised. Only 4 Nos. NMRs are awaiting for regularisation. There is also one candidate awaiting for appointment under Rehabilitation Assistance Scheme.

In this context it is to be mentioned herewith that one post of Watchman is going to be vacated on 01.06.14.

Therefore, it is solicited clarification of the Board whether the preference will be given to the candidate for appointment who is coming under High Court Order or under Rehabilitation Assistance Scheme.

Resolution : Preference be given to NMRs, those who are coming under the judgement of the Hon'ble High Court dtd. 25.09.1992. Hence, the post of Watchman to be vacated on 01.06.14 be filled up by the NMR as per rules.

BoM: 12-13: To consider and approve the MoU formats to be executed between this University and Industry-institute-organizations as recommended by the MoU Committee, TEQIP-II, VSSUT in its meeting held on 25.03.2014.
