(b) Publication of Result of selection withheld due to WPC No.16456 of 2011:

In pursuance to the order of the Hon'ble High Court, Odisha vide Misc.Case No. 11343 arising out of W.P.C.No.16456 of 2011, interviews were conducted for the petitioner Sri Prasanta Kumar Pradhan for the post of Reader in Mechanical Engineering, Reader in Manufacturing Sc. & Engineering and Workshop Superintendent and the result was withheld as there was no direction of the court to publish the result. Now, the petitioner Sri Pradhan has withdrawn the case on 20.08.2015. Hence, approval may be accorded to publish the result of the above selection and issue offer of appointment to the candidate if selected.

(c) Publication of Result of selection withheld due to WPC No. 3876 of 2014:

In pursuance to the Advt. No.VSSUT/Estt/4658 dated 10.12.2013, the interview for the posts of Reader/Assistant Professor in Mechanical Engineering and Production Engineering were held on 02.03.2014 and 03.03.2014 respectively. But in the mean time, the Hon'ble High Court, Odisha vide Misc. Case No.3675 of 2014 arising out of WPC No.3876 of 2014, directed the University vide judgement dated 26.02.2014 to allow the petitioner Sri Prasant Kumar Pradhan to attend the interview scheduled to be held on 02.03.2014 and 03.03.2014 respectively and not to publish the result without the leave of the Court. Now, the petitioner Sri Pradhan has withdrawn the case on 21.08.2015. Hence, approval may be accorded to publish the result of the above selection and issue offer of appointment to the candidates if selected.

Further, the University may be allowed to go for advertisement for filling up of the vacancy if occurs arising out of publication of the above results including the vacancy as stated in Item No. BOM: 17-04(a).
