Madam/Sir,

Inviting reference to the subject cited above, I am directed to say that you were requested vide E-mail on dated 27.02.2018 and this Department letter no.- 15954/HE dated 30.05.2018 for registration under PFMS and EAT module regarding funds allotment under Central Scheme (NSS). All NSS Bureaus have registered under PFMS and EAT module. It is mandatory for all the Colleges/Institutions having NSS Unit/Units to get registered under PFMS & EAT module for transfer of NSS funds. No funds will be released to the Colleges/Institutions having NSS Unit/Units without being registered the same. The letter of Government of India and format for registration have also sent to the NSS Bureau for kind reference. The Ministry of Youth Affairs and Sports Government of India, New Delhi have viewed it seriously that majority of the College/Institutes have not registered under PFMS for which release of NSS funds for conducting programme is getting highly affected for non- compliance (copy enclosed).

You are therefore once again requested to look into the matter personally and instruct the Principals having NSS Unit/Units to take immediate steps for

100% registration under PFMS and furnish the registration ID No. to the State NSS Cell, Higher Education Department by 08.02.2019 positively for onwards transmission of Government of India.
