The HoS, Electrical Sciences suggested to include Optimization and Soft Computing as Advanced Competency Course – 1 in 3 <sup>rd</sup> Semester for all departments in the School of Electrical Sciences only.
AC-2024-34.04	To discuss regarding the withdrawal of Repeat Mid Semester. (Annexure-A5)
	Resolution: The AC deliberated and approved withdrawal of the provision of repeat mid-semester examinations effective from the next academic session: July 2024. Henceforth, repeat mid-semester examinations will not be conducted for any subject unless there are justifying circumstances, such as medical emergencies leading to prolonged hospitalization or other valid reasons (as mentioned in Academic Regulations). In cases where repeat mid-semester exams are permitted due to exceptional circumstances as mentioned above, a penalty of one grade less may be imposed in the respective subject, to be decided by the concerned committee.
	The 7 <sup>th</sup> semester students who are allowed internship shall have to register for NPTEL / MOOCs courses similar to their subjects mentioned in the syllabus. If similar subjects are not available, then they must choose other subjects which have not been offered in any semester. All the subjects must be approved by HoS / HoD in consultation with the SPOC, NPTEL / MOOCs. The sessional subjects (if any) will be conducted in the department after the student joins the university after completing the internship.
