In pursuance to Government of Odisha, Skill Development and Technical Education Department Letter No. SDTE-HTE-HTE-I-0003-2017/4553/SDTE Dated.26/11/2020 and decision taken in the meeting of the Vice Chancellor VSSUT, Dean, Academic Affairs, VSSUT, Director, IGIT, Sarang and Principals of CET, Bhubaneswar, PMEC, Berhampur, GCE, Keonjhar and GCE, Kalahandi on 15.12.2020, it is decided to conduct the spot counselling for the admission into 1st year B.Tech courses for the Academic Year 2020-21, against the non-reported and non-allotted vacant seats after the internal upgradation with the modalities as below.

- (i) The following category candidates will be allowed to participate in the spot admission process of the college against vacant seats.
- The candidates, who have not participated on earlier rounds of OJEE counseling / who have withdrawn from the OJEE counseling process.
 - The candidates who have participated in earlier rounds of OJEE counseling but have not got allotted of seats / allotted a seat but not considered further due to any reason.
 - The candidates who have been issued final allotment letter after final round of OJEE Counselling but did not report at their allotted institution.

- Allotment (2nd Phase Spot Counselling) for any seats remain vacant after 1st Phase.
- Online fee payment for newly allotted candidates (Rs. 20,000/-)
- Reporting at allotted institutes.
