The students need to deposit HoR admission of Rs.2300/- (if not deposited at the time of their admission) in University account/ and Rs.15,000/- towards Mess advance fees in Bank account of (Warden, Respective HoR) through Bank Challan of Canara (Syndicate), VSSUT, Burla/ SBI, Burla.

The students are required to submit the copies (HoR admission fees in University account and mess advance fees) at HoR Warden Office at the time of reporting.

It is advised to all the students of age above 18 (eighteen) years to get vaccinated positively for protection from Corona Virus before arrival at HoR VSSUT Burla and produce the Vaccination Certificate (at least one dose taken positively) at the time of reporting to HoR.

The students of age group below 18 (eighteen) years are required to produce RTPCR negative test report of before three days at the time of reporting to HoR positively.

All possible Covid-19 prevention protocols shall be followed in HoR strictly.

The authority reserves the right to change the Hall allotment if necessary.
