### **NOTICE**

- The wardens of Pulaha HoR have issued a notice on dated 07/05/2022. Further, DSW also issued another notice vide letter no: VSSUT/DSW/438/2022 dated 26.07.2022. Moreover, the wardens of wings C & D issued reminder notice to the boarder for vacating the rooms vide letter no: VSSUT/PHR (BLOCK C&D)/002/2022, dated 26.07.2022. In response to above orders, most of the final year boarders have shifted to wing A&B. However, some of the students are yet to vacate their room from block C & D.
- It has been observed that most of the leftover boarders were provoked by few other boarders not to shift from block C& D.
- On 29/7/2022, Dean, SW, Associate Dean, SW with wardens and Assistant wardens of all wings counsel the students to make the shifting process smooth. After mutual consent, a voting process was suggested for the decision whether all the final year boarders will stay in block A & B or in block C&D.
- Some of the students also proposed to put an option like senior boarders to keep in block A & D and junior boarders to keep in B & C. Then, after a thorough discussion on disciplinary issues and logistic support to control the harmony between junior and senior boarders, it was finalized that the existing order will be reviewed through voting.
- The voting turned out was in favor of existing order.
- In the process of discussion with the boarders, the boarders raised some of issues related to internet, lift, food, water, power backup etc.
- A committee comprising of the boarders, hostel administration staffs need to convene a meeting immediately to address the issues. The issues that can be met from hall development fund under jurisdiction of Warden need to be addressed at the earliest.
- Some of the issues that is pending with University authorities will be accelerated in consulting and chasing with competent authority.
- The leftover boarders are advised to make proper arrangement for their shifting by 02/08/2022. Failing which, disciplinary action will be initiated against the provoking boarders for violating the office orders.
