In pursuance to Government of Odisha, Skill Development and Technical Education Department Letter No. SDTE-HTE-HTE-I-0003-2017/8129/SDTE Dated.06/09/2024, it is decided to conduct the online spot counselling for the admission to 1st year B.Tech and B.Arch courses for the Academic Year 2024-25, against the non-reported and non-allotted vacant seats after the internal up gradation with the modalities as below.

- (i) The following category of candidates will be allowed to participate in the online spot admission process of the university against the vacant seats only.
- The candidates, who have not participated in earlier rounds of OJEE 2024 counselling / who have withdrawn from the counseling process.
 - The candidates who have participated in earlier rounds of OJEE 2024 counseling but have not been allotted a seat / allotted a seat but not confirmed / considered further due to any reason.
 - The candidates who have been issued final allotment letter after final round of OJEE 2024 counselling but have not reported at their allotted institution.

- Counselling fee of ₹ 450 (Non-Refundable) to be deposited through online mode only.
- Choice filling (Select from vacant seats of VSSUT, Burla only).
- Allotment (1st Phase Spot Counselling).
- Option to exercise for FLOAT/FREEZE, Online part admission fee payment for allotted candidates (₹20,000). **The candidates who will not deposit the admission fee will be discarded from the admission process and will not be allotted any seat in the 2nd phase allotment).**
- Allotment (2nd Phase Spot Counselling) for any seats remaining vacant after 1st Phase.

7. Online part admission fee payment for the newly allotted candidates (₹ 20,000).
