Candidates are suggested to come prepared to pay the admission fee through online mode*, after the physical verification of documents. Candidates may also avail hostel accommodation at VSSUT, after completion of admission process. Candidates selected under the Category 1, i.e., "Fulltime students with University Fellowship" will receive a monthly fellowship of Rs. 12000/- (Twelve thousand only) for first two years and a fellowship of Rs. 14000/- (Fourteen thousand only) in third year along with a contingency amount of Rs. 25,000/- per annum (up to 3 years). The fellowship will be automatically cancelled if the progress of a candidate observed to be unsatisfactory. The scholars admitted under University Fellowship category have to take 10 hours of teaching load per week. The authority reserves the right to accept/reject any application or cancel the entire selection process without assigning any reason thereof.
