The proceedings of 12th & 13th meeting of the Board of Management were confirmed with the following observations on the proceedings of 12th BOM on the items as stated below:

BoM: 12-05:

The Board nominee to the Academic Council be also from educational institutions of National importance outside the state for better academic interaction. In this connection, the Board recommends to amend the Act.

BoM: 12-06:

In the agenda notes & action taken the date of joining of Dr. Susant Kumar Paikray, Reader in Mathematics be read as 05.04.2014 instead of 04.04.2011.

BoM: 14-05 To report the status of joining of teachers in the recruitment process-2014 in response to advertisement No.VSSUT/Estt./4658 dated 10.12.2013

The Selection was made in the month of February & March 2014 for filling up of 159 posts of teachers & officers. Out of 159 posts, result for 150 posts was placed in the 12th Board of Management meeting held on 19.05.2014 for approval. The result of 09 posts were kept pending due to the following reasons.

- 1) Six (06) posts of Reader/ Asst. Professor in Mechanical Engineering & 03 posts of Reader/ Asst. Professor in Production Engineering due to interim order passed by the Hon'ble High Court Odisha in WPC No.3876 of 2014 not to publish the result without leave of the Court.

Out of 150 posts, 78 Candidates were selected by the different selection committees & order of appointments were issued accordingly. Out of 78, 72 candidates (Professor-04, Dean, Student Welfare-01, Reader/Asst. Professor-10 & Lecturer -57) joined the posts. Name-position-Departmentwise list of the candidates who joined the University is annexed in (*Annexure – IV: pages from 38 to 39*) for appraisal of the Board.

Further, as per the decision of the Board of Management in its 12th meeting held in 19.05.2014, appointment order for the post of Reader in Computer Sc. & Engineering, Information Technology & MCA was issued to Sri Rakesh Mohanty after withdrawal of the WPC No.18058 of 2011 on 20.06.2014 vide Misc.Case No.9314 of 2014. He has submitted his joining repost on 25.07.2014 for the post of Reader in Computer Sc. & Engineering.

BoM: 14-06 To ratify & approve the recommendation of the Sub-Committee constituted by the Board and follow-up action of the Vice-Chancellor.

On receipt of an anonymous allegation letter regarding selection of the Selection Committee, the Board of Management in its 12th meeting held on 19.05.2014 constituted a Sub-Committee to review the selection of the following posts.

Based on the recommendation of the Sub-Committee, the Vice-Chancellor has issued appointment order for the post of Professor of Computer Science & Engineering, Professor in Information Technology and Dean, Students' Welfare. This is for appraisal and approval of the Board in post-facto.

Further, with regard to post of Controller of Examination the report of the Sub-Committee as above (Annexure-V: page-40) is placed for appraisal and order of the Board.

Resolution : APPROVED IN POST-FACTO with the observation as stated above in BOM: 12-7(i) under Item No. BOM: 14-1 and also observation as stated below:

With regard to Controller of Examination, the BoM rejected the recommendation of the Selection Committee and advised to advertise the post in the next Advertisement.

Further, the Vice-Chancellor is authorised to choose the Board nominee for the Selection Committee for the post of COE which shall be ratified by the Board after completion of the recruitment process in order to maintain secrecy.

At present, 135 teaching posts are lying vacant in different positions. But 107 posts are free from litigation.

The short listing criteria for Asst. Professors at entry level shall be based on the Part-A in the Appendix-VIII of the Statute for 75 marks with details of break-up as given by the Committee and screening test for 25 marks (Total 100 marks). The candidates be called for interview with 1:5 ratio. In case the no. of candidates are less than 05 times the no. of posts, all the eligible candidates will be called for interview.

To consider & approve for advertisement of vacant teaching post on regular basis immediately after clearance from the Hon'ble High Court.

The post of Lecturer (new designation as Asst.Professor) in Mechanical Engg., & Production Engg., are under subjudice. In the mean time we have filed Misc. Cases in the Hon'ble High Court for interim order to Advt. all the posts keeping vacant one post in each until final clearance of the WP(C).

This is for appraisal and needs permission of the Board to go ahead for advertisement as soon as the clearance is received from the Hon'ble High Court as interim or final order whichever is earliest feasible.

The Government of Odisha, Employment & Technical Education and Training Department Vide Resolution No.I-FE-31/2013(Pt.)/6254/ETET dated.25.10.2013 has introduced of 3-Tier system of Teaching Faculties in Under Graduate & Post Graduate Level Technical Institution/ Universities as per AICTE guidelines. The matter was placed in the 12th Board of Management Meeting held on 19.05.2013 for approval. Accordingly, a Screening Committee was constituted by the Vice-Chancellor to examine & suggest the guidelines for re-designation of faculties as Professor, Associate Professor & Assistant Professor. Resolution: The Resolution of the Govt. vide No.I-FE-31/2013(Pt.)/6254/ETET dated 25.10.2013 be implemented. This will be implemented with effect from the eligibility date of the persons concerned. The financial implications be effective from the eligibility date and undertakings be obtained from the persons concerned to refund in case of any objection/excess payment is made. However, the observations on items (vi) & (vii) of the Screening Committee be referred to Govt. for clarification.
