In addition to above, all the students and their parents are required to submit an affidavit, in person at DSW office, towards non-indulgence in any form of indiscipline activity during their remaining period of stay at VSSUT to avoid expulsion or any other severe punishment deemed fit.

Students who have received financial punishment are required to pay the penalty/fine on or before 19<sup>th</sup> April 2025 failing which an additional fine of Rs 100 per day of delay will have to be paid. Receipt copy shall be submitted in the DSW office on the day of payment itself.
