1. Eligiblity

- 1.1 AICTE approved B.Tech., B.E., B.Sc. Engg., AMIE or equivalent in Aerospace / Aeronautical /Civil / Mechanical / Electrical / Electronics / Instrumentation /Chemical Engineering / any Allied discipline of Engineering or Technology.
- 1.2 All such candidates seeking admission in to any M. Tech Programme must have secured **60% (or 6.5 CGPA)** in B.Tech or equivalent examination (Section-B for AMIE).

2. Selection Procedure

The following procedure shall be adopted for the selection of candidates seeking admission into M.Tech.Programmes at VSSUT, Burla.

2.1 Candidates with valid GATE scores and satisfying the requirements as specified in Sections 1.1 to 1.2 can be given direct admission to the M.Tech.Programme based on their GATE score. This is applicable for both General and SC/ST candidates. SC/ST candidates will be considered separately for seats reserved for the purpose.



- 2.2 When sufficient number of GATE qualified candidates are not available for admission into the M.Tech. Programme, students will be selected based on their career marking. They, however, will not be entitled to get any scholarship from Government sources.
- 2.3 For candidates without a valid GATE Score, the Departments shall prepare the merit list based on the career marking as presented in table below under Evaluation scheme.
- 2.4 Candidates who have appeared in their final B.E/B.Tech. Examinations, but results that have not been declared may also be provisionally admitted to the M.Tech.Programme if otherwise found suitable/eligible. However, they shall have to submit the final grade sheet and provisional pass certificate latest by 30th September 2025, failing which the provisional admission shall be cancelled. In this case, the Percentage of marks shall be computed from the marks/grades secured in all semesters excluding the final B.Tech examination. The candidates who would have not submitted the mark sheets/grade sheets of all the semesters except 8th Semester(final) semester, **their cases shall not be considered** for admission into M.Tech.Programme. Copies of the mark sheets/grade sheets should be submitted by the candidates at the time of admission must have been authenticated by their Head of the Institution/College else their cases shall not be considered.

(Universities/Institutions sometimes record their own conversion of marks to grade or vice versa on their grade sheets. Under such circumstances VSSUT, Burla will accept only the original mode of evaluation ignoring the conversion; otherwise, 0.5 shall be deducted from the CGPA for calculation of percentage of marks. If the 8th semester result of the candidate is not declared, then CGPA up to the 7th semester shall be considered for the 8th semester. The candidate having a back paper/fail grade up to the 7th semester, she/he will not be considered on the merit list. However, the candidate should have a pass degree with a minimum eligible CGPA at the time of admission.)

5. Submission of Completed Application Form

The interested candidates have to fill the online application form using the link: <u>https://eadmission.vssut.ac.in</u> available in University website: <u>www.vssut.ac.in</u>.Candidates have to pay a non-refundable application fee of Rs.500/- (Rs.200/- in case of SC/ST candidates) for completing online application. **Duly signed hard copy** of the online application along with the relevant documents as mentioned below should reach **Dean**, **PGS&R**, **VSSUT**, **Burla**, **Pin-768018 by 01.08.2025**, **5 PM** through **Speed / Regd. Post** only. The envelope containing the application should be superscribed as "**Application for M.Tech Programme in Aerospace Engineering 2025**".

6. Documents to be Enclosed

- 1) Hard copy of duly filled in and signed online application form.
- 2) Self-Attested copy of certificate of 10th/ Equivalent Examination.
- 3) Self-Attested copy of certificate of +2 Sc. / Equivalent Examination.
- 4) Self-Attested copy of certificate of B.Tech / Equivalent Examination.
- 5) Self-Attested copy of Grade sheets / Mark sheets of the 10th/ Equivalent Examination.
- 6) Self-Attested copy of Grade sheets / Mark sheets of the +2 Sc. / Equivalent Examination.
- 7) Self-Attested copy of Grade sheets / Mark sheets of all the semesters of B.Tech / Equivalent Examination.
- 8) Self-Attested copy of valid GATE Score.
- 9) Self-Attested copy of SC/ST caste certificate, if applicable.

The Candidates, who have not passed the final B.Tech/ Equivalent Examination, but have already appeared the above examination, shall submit (upload) the following documents in place of the documents mentioned in Sl. Nos.4 and 7.

(i) Appeared certificate of final Semester of B.Tech/ Equivalent Examination from the Head of the institution in the original.

(ii) Grade Sheet/ Mark sheets of all the Semester of B.Tech/ Equivalent Examination except final Semester duly authenticated by the Head of Institution.



- i. Online application form along with other relevant documents will be scrutinized by the respective departments.
- ii. After departmental scrutiny, first merit list will be published in the University website. (www.vssut.ac.in)
- iii. Cadidates will be called for Offline-Councelling-Cum Admission process based on their names in the merit list.
- iv. Those candidates who fails to attend the Offline-Councelling-Cum Admission on specified date and time, will loose the claim over the seat. It will be presumed that the candidate is not interested to take admission at VSSUT. Hence the seat will be allotted to the next candidate in the merit list.
