(i) The following category candidates will be allowed to participate in the spot admission process of the college against vacant seats.

- The candidates, who have not participated on earlier rounds of OJEE counseling / who have withdrawn from the OJEE counseling process.
- The candidates who have participated in earlier rounds of OJEE counseling but have not got allotted of seats / allotted a seat but not considered further due to any reason.
- The candidates who have been issued final allotment letter after final round of OJEE Counseling but did not report at their allotted institution.

- Online fee payment for newly allotted candidates (Rs. 20,000/-)
- Reporting at allotted institutes.
